
All five sites offer drive-through service with an employee handing meals to each driver. We follow strict cleanliness and safety guidelines.


A limited number of meals are available at each location. We will monitor demand at each site and adjust the number of meals provided. Our goal is to provide meals for any child who needs them.

## **Summer Food Service Program**

The Rush-Henrietta School Nutrition Program is participating in the U.S. Department of Agriculture's Summer Food Service Program, which provides free meals to students during the summer. All kids in the community, 18 years and younger, can participate; you need not be a Rush-Henrietta resident.
