SHARED-HOUSING AFFIDAVIT

Please fill out, notarize, and return to the Office of Student & Family Services/Registrar. The following information must also be included:

From you –

- 1. Two forms of acceptable proof of shared residency. These can be an auto insurance policy, current bank/financial statement, current pay check stub, and current bill with address listed.

From the homeowner/lessee –

- 1. Copy of the mortgage agreement, school or county property tax bill, deed, or monthly mortgage statement/coupon book or a copy of a valid lease.

This is a legal document. Any person giving false information may be subject to prosecution for perjury, a crime. Inclusion of false information may make you liable for the payment of tuition costs for the student. The information provided by you will be used by the Rush-Henrietta Central School District to determine whether a child is entitled to a free education in the Rush-Henrietta Schools. **Every question must be answered or the Affidavit will not be considered.**
