8. TEENAGE DRUG USE WORKSHOP

Ms. Nerlande Anselme, Assistant Superintendent for Student & Family Services, introduced Shari Hogan, School Nurse Teacher, and Paul Swiatek, Drug Counselor at the Senior High School. They were there to present the Board with an update on Teenage Drug Use.

Ms. Hogan started her presentation by outlining the opiate addiction has become a national epidemic. She explained that morphine is the active ingredient in Vicodin, OxyContin and Percocet. It takes only 4 days for your body to have a physical dependence. Since 2000, deaths have increased by 200%. Heroin has increased at an alarming rate as well and all Rush-Henrietta nurses have a Naloxone kit (overdose kits) and are trained in its use.

Mr. Swiatek reported on the different drugs available and their narcotic effect. There has been an increase in the use of painkillers. Alcohol remains a problem; however, numbers are going down; along with cigarette usage. It was noted that E-cigarette use has increased and is also addictive. With the legalization of marijuana, that too is becoming more popular.

Mr. Swiatek has been very active in connecting with parents, kids, and the community to inform them of these trends and issues in and around our community.

9. Workforce Diversity

Dr. McCue presented a workshop on the variety of ways we seek to maintain a diverse workforce. Some of these include broadening the pool, doing a better job identifying potential candidates, a more careful screening process, and additional recruitment trips to obtain a diverse group of candidates. Mr. Banister and Mr. Cook offered suggestions to make diversity outreach even more robust.
