Summary & Background

On March 11, 2021, President Biden signed into law the American Rescue Plan (ARP) Act of 2021. The ARP Act included an unprecedented \$800 million reservation within the Elementary and Secondary School Emergency Relief (ESSER) Fund to support the specific and urgent needs of homeless children and youth in recognition of the extraordinary impact of the coronavirus disease (COVID-19) pandemic on students experiencing homelessness. The Department is administering these funds through the ARP Homeless Children and Youth (ARP-HCY) Fund.

The ARP-HCY fund was created for the purposes of identifying homeless children and youth, providing wraparound services in light of the impact of the COVID-19 pandemic, and providing assistance needed to enable homeless children and youth to attend school and participate fully in school activities, including in-person instruction this spring and summer learning and enrichment programs.

After reserving \$1 million of the \$800 million (0.125 percent) for national activities including technical assistance, the USDE awarded the remaining \$799 million to State educational agencies (SEAs) as follows:

\$199,750,000 (25% of the \$799 million) was made available to States immediately. NYSED received approximately \$14,720,327 in this disbursement. This disbursement was designed to provide funding to States immediately as a supplement to their McKinney-Vento Education for Homeless Children and Youth HCY funds, so that States can address urgent needs of homeless children and youth—including academic, social, emotional, and mental health needs—and so States and local educational agencies (LEAs) can increase capacity by hiring staff, dedicating resources, and planning partnerships with community-based organizations, among other strategies. Funds must be administered by the Office of the State Coordinator for the Education of Homeless Children and Youth, consistent with the requirements for HCY funds. These funds were disbursed to eligible LEAs through the ARP-HCY Part I Application issued in November 2021.

\$599,250,000 (75% of the \$799 million) was made available to States after submitting the required application to USDE. Upon approval of New York's State Plan by the USDE, NYSED received approximately \$44,190,109 in the second disbursement. States are required to distribute the funds they will receive in the second phase to LEAs via a formula that uses the LEA's allocation under Title I, Part A (Title I) of the Elementary and Secondary Education Act of 1965 (ESEA) and the number of identified homeless children and youth in either 2018-19 or 2019-20, whichever was greater. Timeline

Funds appropriated under the ARP-HCY program will be available for obligation until September 30, 2024.

This year, students experiencing homelessness are moving from one place to another more often, which we believe is due to COVID. This frequent moving is having a severe impact on regular attendance at school, and most are struggling academically as a result. In addition, depression and anxiety are very prevalent among this group, giving them a sense of hopelessness. Significant social media conflict and aggressive behavioral issues have risen this school year among the student population as a whole, and this is prevalent among students experiencing homelessness as well.

- Identify historically underserved populations such as rural children and youth, Tribal children and youth, students of color, children and youth with disabilities, English learners, LGBTQ+ youth, and pregnant, parenting, or caregiving students experiencing homelessness.
- Increase capacity by hiring staff, dedicating resources, and planning partnerships with community-based organizations, among other strategies. The secondary building leaders will be working with appropriate staff, such as their school counselors, to review first semester academic and behavioral records of students experiencing homelessness, as well as students identified as English Language Learners, students with special needs, youths of color and youths identified as members of the LGBTQIA community, to ascertain current learning and enrichment program needs. It is important to note that other than the groups mentioned, the district does not have other populations such as tribal children and youth. Based on the conversations that we engaged in recently, one of the most pressing needs that they have for the populations mentioned is the need for additional extra-curricular opportunities to help these students stay connected to their school community in a positive way. For example, one of our junior high school principals would like to re-establish the "step team" club this spring for the youths at her school, and the other leaders expressed the same interest. Some of the resources would be dedicated to paying a staff member to be the advisor and provide appropriate supervision for the students. In addition, the advisor would aid in monitoring students' progress in the school both academically and behaviorally.

We are currently also focusing on identifying students who are experiencing homelessness and those in historically underserved populations who may be failing one or more courses. We would work with our district tutors to expand their hours to provide academic intervention to these students after school, and in some cases, remotely on weekends. In addition to support that will be available to students failing courses, we would provide tutoring help to support students who need review and better preparation for the 3-8 grade ELA/Math, NYSESLAT and Regents exams.

Currently, our school counselors are working with our seniors experiencing homelessness and helping them with the transition from high school to either the world of work or post-secondary education. Some will need assistance with paying application fees and Advanced Placement exam fees. Additional funds/resources will need to be set aside to remove these barriers for the senior class this year and for the current junior class next school year.

- This spring, and as the end of the school year approaches, we will be focusing on identifying students experiencing homelessness, our students of color, ELLs, LGBTQIA youth and students with disabilities who will need summer learning and summer recreation programs. Some of the students will be attending summer school through our partner at Monroe One BOCES. Others will be attending our district-run Extended School Year (ESY) program and English as a New Language summer programs, with transportation being provided to these students.
- Work with community-based organizations for this purpose, as well as to provide wraparound services to these students.

For summer wrap-around services, we will work with our community-based recreation department through the Town of Henrietta so that the students will have the opportunity to participate in various youth sports and recreation summer programs. Examples of these include: gymnastics, indoor tennis, martial arts, youth cheerleading, STEM, and First Aid training.

The social-emotional well-being of all students continues to be our focus. Our mental health staff, along with our partner agencies, The Healing Connection and the University of Rochester Behavioral Health are working together to provide Tier 1-3 levels of intervention depending on students' individual needs.

Program Narrative

 In the space provided below, please describe the extraordinary impact of the pandemic on students experiencing homelessness, including academic, social, emotional, and mental health needs.

This school year, students experiencing homelessness move from place to place more often, which we believe is due to COVID. This frequent moving has a severe impact on regular attendance at school, and most are struggling academically as a result. Additionally, depression, anxiety and overall sense of hopelessness continue to be more prevalent among this group. Social media conflict and aggressive behavior have risen this school year among the population as a whole, and is prevalent among students experiencing homelessness.

 - Increase capacity by hiring staff, dedicating resources, and planning partnerships with community-based organizations, among other strategies;
 - Focus on identifying students this spring and to connect students experiencing homelessness and their families
 to summer learning and enrichment programs this summer (summer 2022), and to engage students and their
 families in preparation for this fall;
 - Identify historically underserved populations such as rural children and youth, Tribal children and youth, students of color, children and youth with disabilities, English learners, LGBTQ+ youth, and pregnant, parenting, or caregiving students experiencing homelessness; and
 - Work with community-based organizations for this purpose, as well as to provide wraparound services to these students

These activities may include any expenses necessary to facilitate the identification, enrollment, retention, and educational success of homeless children and youth.

The additional ARP-HCY funding will be used first for connecting students who are experiencing homelessness to academic and other available learning opportunities during the summer and throughout the school year. While some of the students are attending summer school, we would use the resources to provide additional tutoring so that the students would have a high chance of successfully completing required courses for graduation. During the 2022-2023 school year, any student identified as homeless will also be provided additional tutoring support afterschool, remotely or in-person to ensure that at the onset, they can successfully complete all of their scheduled classes. Twice a year, we provide intercession opportunities where students who are failing courses will have the chance to work with a teacher for a

week to maximize their potential for success. Therefore, we will also use some of the funding to increase the capacity of additional staffing to offer more course make-up offerings during intercession periods to allow students experiencing homeless an additional avenue to be academically successful in courses they are failing during the school year.

To address the mental health needs, we are in conversation with a community agency partner, University of Rochester Behavioral Health, who provides expanded mental health support to our students at the elementary level and are requesting of them to provide that support next school year at the secondary level as well. If they are able to expand the support at the secondary level, a portion of the funding will be used to ensure that the students experiencing homelessness are given priority. Mental health support with the agency will be made available within the school setting and at times, at their clinic locations for students experiencing homelessness. We understand that on-demand access to these supports are key to students experiencing homelessness long-term success.
