Board Proposes Full-Day Kindergarten, School Reconfiguration


After much consideration, the Rush-Henrietta Central School District Board of Education in November unanimously approved a proposal that would allow the district to offer full-day kindergarten, manage future enrollment, and meet the changing academic, emotional, and social needs of all students. The proposal calls for a school reconfiguration that will serve our students and community for the next several decades and addresses many concerns shared by parents throughout the years.

As outlined in a June 2013 *Henrietta Post* story about student enrollment, the district has been examining ways to meet the changing needs of its students for several years. Among the major challenges facing us now and in the future: We do not have enough classroom space to provide full-day kindergarten and keep our successful small-class-size initiative intact. Of equal concern, our elementary schools are becoming too dissimilar in size, a trend that will become more pronounced in future years.

In 2012, Superintendent Ken Graham asked the Instructional Space Committee to begin sharing ideas about how the district could provide full-day kindergarten given its space restraints. Last winter, the Board of Education directed Dr. Graham to recommend a plan that would allow for the implementation of full-day kindergarten. While researching this, he sought feedback from all corners. In September, Dr. Graham met with staff members from each school to discuss options and ask for their feedback. In October, he discussed possibilities with parent leaders who comprise the District Parent Advisory Council.

All told, the board evaluated more than a dozen alternatives and narrowed them down to two. The first alternative – adding a wing to each elementary

Public Hearing To Be Held Tuesday, Dec. 2, Regarding Veterans Exemption

In 2013, the New York State Legislature granted school boards the right to offer property tax exemptions to eligible veterans. The Rush-Henrietta Central School District Board of Education soon will deliberate regarding the granting of the Alternative Veterans Exemption, which provides a partial break from school district property taxes to eligible war-time veterans and their spouses. If an exemption is granted to veterans, it will result in an increase in taxes to those taxpayers not eligible for the exemption. Input from the community is sought as to whether to grant the

Veteran Exemption for recognition of service to our country, which would result in a higher tax burden for nonqualifying taxpayers. Residents are welcome to speak during a public hearing at the Board of Education meeting scheduled for 7 p.m. Tuesday, Dec. 2, in the Dee Strickland Conference Room at the Parker Administration Building, 2034 Lehigh Station Road, Henrietta. Frequently Asked Questions Regarding Potential Veterans Exemption

Q. What is the Veterans Tax Exemption?

municipalities to give veterans a reduction on their property taxes that was amended to permit school boards to do the same if they choose. Providing this exemption is a choice each district Board of Education must make based on what they believe is best for their community. School board members need to be certain that their community understands and supports any action that would increase tax bills for a large number of residents.

Q. How does this law affect school districts?

A. The law provides that boards of education have the option of approving a partial exemption on school property taxes for the primary residence of veterans who served in

defined periods of war or received an expeditionary medal for their service, and also for certain surviving members of their families. This would reduce the assessed value of a veteran's property in the following ways:

- By 15 percent for veterans who served during a time of war,
- By an additional 10 percent for veterans who served in combat,
- By one-half of a veteran's disability rating for veterans who sustained service-related injuries.

These percentages are subject to maximum dollar limits set by the state and chosen by the board.

Q. What does the state currently do for our veterans?

New York veterans receive the following forms of financial support in recognition of their contributions:

 Military pensions are exempt from state income tax.

- Veterans who pass the Civil Service exams receive 5-10 extra points for being a veteran.
- The state provides veterans lower mortgage rates, assistance with closing costs, and no points.
- Veterans of combats since 1961 can receive tuition payments for undergraduate and graduate programs for up to the full cost of SUNY tuition or actual tuition, whichever is less.

What does this mean for non-veterans who pay school taxes?

An exemption for one group means taxes will increase for other residents not in that group. In this case, non-veterans would pay a higher share of school taxes to make up for the revenue lost by granting the exemption. If approved, the exemption would add between 0.6 percent and 1.7 percent to the tax rate for non-veterans.

School Board Members Set 2014-2015 Goals

Much like our students and staff, the seven members of the all-volunteer Rush-Henrietta Central School District Board of Education have set goals for themselves this year. My colleagues and I would like to share some of these objectives with you and reinforce our desire to remain in close communication with you this school year.

Our first goal this school year is to engage in strategic planning that will benefit the district in the long-term. In addition to participating in the annual strategic planning forum and adopting district priorities, both of which have been completed already this year, we look forward to finalizing plans for full-day kindergarten, adopting an instructional space plan, engaging in a comprehensive review of our ASL program, and reviewing the district mission.

Second, in terms of policy and governance, we will continue our annual review of one-third of school district policies and regulations. By doing this, we are able to review all Rush-Henrietta policies and regulations every three years. We also will continue efforts to formalize mechanisms for recognizing memorials and

scholarships. At the same time, we will develop scholarship fund criteria and a process for acknowledging memorials.

Third, we will seek to make wise decisions in the areas of staffing and resource management. We plan to adopt a financing plan for full-day kindergarten, adopt a proposed 2015-2016 budget, and review and update our reserve fund plan.

Finally, we will continue to advocate externally for our school district by increasing our awareness of legislative issues at both state and national levels. We will be more engaged in state and county associations and in legislative

lobbying efforts, using our experiences to benefit our school district. In addition, we plan to put our many years of leadership to use, continuing to share best practices with other boards throughout the state.

Ronald Boillat Class of 1977

Ronald Boillat, a member of the Rush-Henrietta Class of 1977, has enjoyed a successful business career supporting start-up ventures, turnaround situations, and established entities.

His initial business experience was at ACC Long Distance, a regional

carrier in Upstate New York. Ron spent eight years at this startup, ending his tenure as vice president of sales and marketing. He spent the next 12 years in the wireless industry, six with Cellular One as vice president of sales and marketing. He oversaw the day-to-day operations of the company and played a key role in shaping the strategic direction of the company.

Ron later joined Frontier Cellular, which was facing a significant challenge. Its growth was well below industry averages and it was losing money. By developing and executing an aggressive strategic plan, including implementation of CDMA technology ahead of its competitors, Ron was able to help the company post record growth that outpaced the industry. From 2001 to 2009, he served as president of Current Communications, a privately held company.

Today, Ron serves as chief development officer at Rochester-based Sweetwater Energy. The company uses a patented technology to produce low-cost sugar solutions from non-food biomass. This sugar solution is sold to refineries, which use it to produce biofuels, biochemicals, and bioplastics. Unlike petroleum-based technologies, this unique process significantly reduces greenhouse gases. Ron is responsible for the design, deployment, and operation of Sweetwater's demonstration plant in Rochester and its commercial facilities that will open throughout the United States during the next two years.

In addition to his successful business ventures, Ron has been involved in his community. His volunteer service includes sitting on the board of directors at Bivona Child Advocacy Center, the National Center for Missing and Exploited Children, and the Cystic Fibrosis Foundation. He also has coached youth baseball, football, and soccer for more than a decade. Ron was honored with the Rochester Business Journal's prestigious "40 Under 40" award, which recognizes men and women 40 and younger who have achieved professional success and made significant contributions to our community.

A member of the 1976 state champion football team, Ron remembers his time at Rush-Henrietta fondly. He lives in Pittsford.



Sherry Powers Finzer Class of 1981

Sherry Powers Finzer, a 1981 Rush-Henrietta graduate, is an internationally known flutist and recording artist.

A renowned flutist, Sherry blends her classical training with music from the pop and jazz eras, composing and performing contemporary instrumental compositions, and using her music

as a way to help people heal both mentally and physically. As a classical flutist she has won local and national flute competitions.

Sherry is a performing artist for the Pearl Flute Company, based in Japan, and Gwo Flutes, based in Taiwan. She recorded her first solo album, Desert Journey, in 2007. Two years later, she began recording her Sanctuary series of New Age/Healing music on the Heart Dance Records label. Her most recent release, Transformation, was named Best Album 2013 by the United Kingdom-based One World Music.

Sherry's music can be found on iTunes, Pandora, and Amazon. In 2015, she will tour internationally with Australian pianist, Fiona Joy, and in the United States with Native American flutist, Mark Holland.

Even while in the midst of her greatest professional success, Sherry continues to look for ways to make positive contributions to her community. In 2009, she founded the Arizona Music Initiative, a not-for-profit organization designed to inspire, educate, and entertain children, seniors, and people with special needs. In addition, she is a regular volunteer at several Phoenix-area middle schools, where she assists band directors in getting the most out of their flute sections. Reflecting on her own schooling, Sherry credits Howard Rowe, one of her high school music teachers, for encouraging her passion for musical performance.

Sherry has served as program chair for the Arizona Flute Society for three years and is a member of the National Flute Association and World Flute Society. She hosts a weekend radio show each Saturday and Sunday on Positive Music Radio at www. postivemusicradio.net.

Sherry lives in Phoenix with her husband, Chuck, a 1981 Rush-Henrietta graduate. They have two sons, Nick and Tyler.

Harry Howitt Class of 1964

Harry Howitt, Ph.D., a 1964 Rush-Henrietta graduate, is a retired United States Air Force colonel who has spent his professional career helping others as a clinical psychologist. He enjoyed a 33-year military career, during which he was described as a "superstar leader."

A Vietnam veteran, Harry was assigned to the Military Advisory Command in Saigon in 1969. During his active military service, he received the Air Force Meritorious Service Medal four times for outstanding performance at a military installation.

A lifetime member of the American Psychological Association, Military Division, Harry earned many other honors, including being named Air Force Psychologist of the Year. He also received the Legion of Merit Medal. This recognized his high level of performance and dedication to the military both as a psychologist and for his leadership while serving as a commander for a Medical Operations Squadron, at the Air Force's largest Behavioral Medicine Department, and as hospital commander at Little Rock Air Force Base, Arkansas. He also served as president of the Air Force Society of Clinical Psychologists.

Since retiring in 2003, Harry has worked full-time at the Joint Military Base, located at Fort Sam Houston in Texas. He serves as a behavioral health psychology consultant to all branches of the military, helping airmen, sailors, and soldiers reach their full potential.

Harry is a member of the Men's Health Network Advisory Board, a distinguished group of professionals who are dedicated to raising public awareness about mental health. As part of his work with the Men's Health Network, Howitt contributed to a booklet titled, "Your Head: An Owner's Manual." The book addresses anxiety, depression, and stress.

The Men's Health Network is just one of many successful endeavors in which Harry has been involved. As Brig. Gen. Garry Trexler wrote of the airman while recommending him for a promotion, "Everything he touches turns to gold."

Harry credits Mr. Elliott, Mr. Pruden, Ms. Theofanis, and Mr. Rittenhouse for helping to shape him, his interests, and future success while he was a student at Rush-Henrietta.

Donna graduated with a dual MBA degree from Atlanta University and spent 13 years in Georgia, building her business skills and expanding her faith-based initiatives. She has enjoyed a rewarding career in information technology, working for some of the biggest names in business, including 3M, UNISYS, Xerox Corp., Amoco Oil/BP, and MCI/WorldCom. 
As part of the district's fiveyear technology plan, more than 400 Chromebooks were issued to students in September. The plan involves expanding district infrastructure and acquiring devices

that will provide instant access to the Internet and web-based tools for all students. The goal is to make technology a universal tool that is used by everyone in the classroom. The entire plan can be viewed at www.rhnet.org/technologyplan.

Providing Chromebooks to all seventh graders is one of the first steps in the five-year plan. According to an August 11, 2014, story in *The Guardian* newspaper, "Chromebooks run a stripped-down form of Linux tuned by Google and hook into Google's cloud

New Website Provides Easier Access to Sports Team Information

We have great news to share about exciting improvements in how sports team schedules are maintained and shared by the Rush-Henrietta Central School District!

The Monroe County Public School Athletic Conference has a brand new website that offers sports information for 23 local school districts, including Rush-Henrietta. The site is available at www.rhnet. org/sportsschedules or by clicking the "Sports Schedules" link on the left side of the district homepage at www.rhnet.org.

The new site allows you to easily view Rush-Henrietta athletic events by day of the week, an entire week, or a full month or season. Want to cheer on the varsity girls soccer team? Once you choose a specific game, a pop-up box will provide the time, date, location, and driving directions. You can print this information or share it with friends and family members on Facebook or Twitter with the click of a button!

Interested in the entire varsity girls soccer schedule? Just click "Soccer - Girls Varsity" and select

"View." A pop-up window displays the schedule for the entire season. The site is designed to provide instantaneous updates to athletes and their families. As soon as a district enters information or makes a change to the schedule, you will see it online.

Safety Comes First in Rush-Henrietta Schools

As part of our ongoing efforts to make our schools as safe as possible, the Rush-Henrietta Central School District held daily safety drills during the first week of November. These drills were designed to assess how well we would respond during an emergency. They included:

- a visitor management drill, designed to assess how well visitors are greeted, screened, and identified when they visit.
- an early dismissal drill. The school day ended 10 minutes early and students were sent directly to their bus.
- an AED/CPR drill to ensure that the staff members trained in the use of the automated external defibrillator are prepared to act at a moment's notice.
- a lockout drill. During this kind of drill, all school doors are locked and no one is allowed to enter or exit the building.
- a K-9 sweep at each of our secondary schools performed by the Monroe County Sheriff's Office.

This year, Rush-Henrietta continues to use a visitor management system designed to offer additional security for students, staff members, and visitors. Visitors must show photo identification upon entering any Rush-Henrietta school. This step is necessary even if the person is well known to the staff members who greet them. The photo is scanned, stored, and printed on a badge that must be worn for the duration of the visit. The badge indicates the date, visitor's name, and a specific school location, depending on the reason for coming to the building. After 12 hours, red lines will appear on the badge, rendering it null and void. Once the photo is scanned and stored, it will be accessible when visiting any Rush-Henrietta school.

We continue to partner with the Monroe County Sheriff's Office and local fire and ambulance crews to prepare for emergencies. In addition, the district offers a Safety Tip Line (359-7867 or 359-STOP), which allows any community member to report situations that may pose a threat to the safety or well being of students, staff members, or school property. The tip line is monitored regularly and all calls remain confidential.

Thank you for partnering with us as we continue our efforts to make the Rush-Henrietta Central School District a safe place for students, staff members, and the community at large.

school – addressed the district's minimum goal of adding extra space needed to provide full-day kindergarten. In talking to parents and staff members, it became clear that, rather than adding more space to each elementary school to accommodate full-day kindergarten, the entire student body could benefit from a more comprehensive school reconfiguration.

Those conversations led to a second alternative – the one approved by the board – in which the district would have four K-3 schools, two 4-6 schools, and two 7-9 schools. The Senior High School would continue to house grades 10-12. All programs at Vollmer Learning Center would move to the Webster Building, which is now the Ninth Grade Academy.

This alternative would provide the space needed for full-day kindergarten and allow us to bolster programs and services for all students. We look forward to sharing examples with you in the weeks to come. These include enhancements to our academic, athletic, and music programs; additional instructional time in ELA and math; and the potential for wrap-around child care at our elementary schools, among others.

Both alternatives required redistricting of attendance areas to ensure that our schools are equitable both in terms of their physical space and number of students. The Instructional Space Committee was preparing to discuss attendance areas as the newsletter went to press.


Given that both alternatives cost roughly the same amount, the Board of Education voted to pursue the option that reconfigures the schools for maximum long-term

benefit. The proposal costs about \$18 million. The district has saved the money in reserve funds, so there would be no impact on school taxes should residents approve the proposal.

A public vote will be held Tuesday, Feb. 10. If the proposal is approved, the Board of Education would direct district staff to implement these changes, which would go into effect as early as the 2017-2018 school year. If it is defeated, the Board of Education will revisit the other alternative, which provides additional space at our elementary schools without the program enhancements for all students.

The district will continue providing information via the district website, Facebook page, and through the mail. In December and January, members of the Board of Education will attend a parent group meeting at each school, explaining the proposal and answering questions. In addition, the district will hold two community forums in January. The times and locations for these meetings will be set soon. We encourage you to attend!
